# **Privacy Policy**

This Privacy Policy ("Policy") explains how **407 Sports LLC dba 407 Basketball** ("407 Basketball," "we," or "us") collects, uses, and protects personal information. #### **Notice at Collection**

We may collect the following categories of personal information:

- **Children's Information** (when provided by parents/guardians for youth programs, camps, leagues, or training)

- **Demographic Information** (age, gender, ZIP code, residency)
- Internet & Cookies Data (IP address, browsing activity, device identifiers)

We collect this information directly from you, through your use of our Platform, and from third parties such as payment processors, event partners, or social media sites.

### **How We Use Your Information**

We may use your information to:

- Provide and improve our sports programs, memberships, and events
- Process payments and manage accounts
- Communicate with you about schedules, registrations, and promotions
- Understand your interests (sports, events, schools, training programs)

- Protect the safety of our athletes, families, and staff
- Comply with Florida and federal legal requirements
- Market programs, events, and sponsorships (unless you opt out)
- Support scholarship and school program verification (e.g., Step Up for Students, FLVS)

#### **How We Share Your Information**

We may share your personal information in the following ways:

- With service providers (payment processors, website hosts, email vendors)
- With business partners (local schools, leagues, sponsors, and event partners)
- For legal or safety purposes (to comply with Florida or federal law, protect against fraud, or ensure athlete safety)
- With successors (if our business undergoes a merger, acquisition, or sale)
- As directed by you (for example, if you ask us to share your registration details with a coach or school)

We do **not sell** your personal information.

## Florida & U.S. Privacy Rights

Under Florida law and applicable U.S. privacy laws, you may have the right to:

- Request access to the personal information we have collected about you
- Request that we correct or update inaccurate information
- Request that we delete your information (subject to legal and program obligations)
